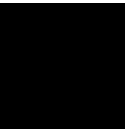
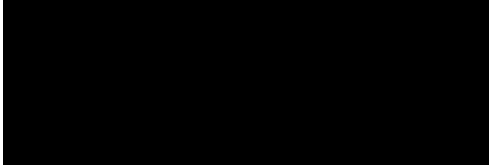

We look forward to working with you towards providing nutrition supports for your family.

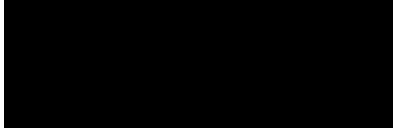

Need help because of disability?

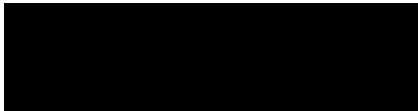
If you have trouble doing something we asked you to do because of a physical or mental health problem:
