Legal Permanent Residents (LPRs) that have 40 quarters of work experience may be eligible for SNAP benefits. A quarter of coverage is any calendar quarter as follows:

- January 1 to March31
- April 1 to June 30
- July 1 to September 30
- October 1 to December 31

The individual must have a specified amount of wages or self-employment income in each quarter to count that quarter.

A noncitizen client may claim work quarters if they:

- Have worked a minimum of 40 qualifying quarters under Title II of the Social Security Act; or
- Can be credited with a total of 40 qualifying quarters under Title II of the Social Security Act as worked by a combination of:
 - The noncitizen
 - The parent(s) of the noncitizen while the noncitizen was under age 18 including quarters worked before the noncitizen was born or adopted even if the noncitizen was not present in the US when the quarters were earned, and/or
 - The spouse of the noncitizen during their marriage if the noncitizen remains married to the spouse or is widowed

Note:	You cannot use any quarter claimed after 12/31/96 if the LPR received any assistance from a		
	federally means tested program (see Guide for full listing)		

Verification of Work Quarters

A client may make a self-declaration as to working 40 quarters but you must verify this with one of the following:

- a current employer –prepared statement of earnings
- W-2 and W-2c, employer-prepared wage statement or an IRS copy of the individuals tax return
- a timely filed tax return for a self-employed individual

Note:	You must be sure that the proof of filing, canceled check, money order or copy of IRS	
	schedule C form bearing the IRS time stamp indicates the return was filed within 3	
	years 3 months and 15 days after the end of the year in which the self-employment	
	income was derived.	

- other evidence of self-employment that allows you to determine that a business did exist and that a profit was earned. Comparison of bills, payment vouchers, and receipts are examples of evidence you might use to make a determination
- records of employment agencies in Massachusetts or any other state
- any other evidence of earnings including pay envelopes, pay vouchers, union records, or an individuals copy of a Federal or State tax return
- Social Security Administration Records of a non-recipient

Note:	If the client states that they can claim work quarters from a spouse or a parent who
	worked before the noncitizen turned 18 you can request that the client obtain
	verification from the non-recipient client, spouse or parent. If the non-recipient client,
	spouse or parent refuses to cooperate the information can be obtained from SSA by
	using a Request for Quarters of Coverage History Based on Relationship SSA-513 form.

- Social Security records for recipient clients can be requested from the Social Security Administration (SSA) by checking the "Claims 40 quarters" box on the Non-citizen page of BEACON

Notes:

- Quarters earned in any country not listed above may not be counted toward the 40 qualifying quarters.
- The LPR is eligible for up to six-months of SNAP Benefits until the quarters are verified. If you receive information that the client does not meet the 40 qualifying quarters you must make the noncitizen ineligible for the program. If the noncitizen has less than 40 quarters and fails to qualify for benefits, recoupment of the benefits provided is not required.
- Verification of Work Quarters can be requested from the Social Security Administration (SSA) by
 entering the Legal Permanent Resident Page of BEACON and selecting yes in the "40 Quarters Claimed"
 field (Click on the link "Entering Legal Permanent Resident data in BEACON" below for
 instructions). Once a request has been made a report will be sent within a few weeks to "Actuate
 Report Finder" detailing the work quarters of the noncitizen applicant.
