


The Impact of Immigrants in Massachusetts

Regions of Origin



Immigrants are vital to the Commonwealth:

- Massachusetts is home to over 1 million foreign born residents, almost 16% percent of the total population.
- 1 in 5 workers in MA are foreign born, making them essential for the preservation and growth of the economy.
- Of the foreign born population more than half (52 %) are naturalized and the rest are noncitizens.
- 15.5% of registered voters are naturalized immigrants or U.S. born children of immigrants.

Economic Contribution of Immigrants

Latinos and Asian immigrant entrepreneurs contribute tens of billions of dollars and tens of thousands of jobs to the economy of Massachusetts

- 21 percent of entrepreneurs in MA are immigrants, employing 134,477 people.
- 58% of Fortune 500 businesses in MA were founded by Immigrants.
- Immigrants earned 15% of all income in MA and contributed around \$4.5 billion in federal and \$3 billion in local and State tax revenues.
- Through their individual wage contributions, immigrants also paid about \$4.6 billion into the Social Security and Medicare programs that year.



Social Impact of Immigrants



Massachusetts has an aging population and immigrants and the children of immigrants are vital for supplying workers for the economy now and in the future.

- Without population growth from immigrants, the state population would have declined by three percent.
- The Commonwealth faces a shortage of STEM and healthcare professionals. Immigrants help fill up the huge gap between advertised positions and supply of professionals in industries that keep our knowledge-based economy thriving.
- 28 percent of children under 18 in Massachusetts are growing up in families with at least one immigrant parent. 86% of these children are U.S. born.

If all unauthorized immigrants were removed from Massachusetts, the state would lose \$12.0 billion in economic activity, \$5.3 billion in gross state product, and approximately 55,467 jobs.
