

**Table 1: MLRI Update on People Losing Health Coverage, March 30, 2015**

There are two different groups of people who recently lost health coverage or are about to lose coverage. This is confusing, but it's important to keep the two groups straight. They are in different situations and the ways to help them get coverage are different too.
