

New Eviction Record Sealing Law

- As of May 5, 2025, a new law gives certain tenants the ability to "seal" an eviction record
- "Seal" means that an eviction record will no longer be publicly available
- Sealing clinics are happening across the state

Statewide Access to Counsel

- For eight years, MLRI worked with our partners and over 240 supporters to pass a statewide Access to Counsel Program.
- In FY25, Massachusetts legislature passed a dedicated line item for an Access to Counsel pilot program with seed funding of \$2.5 million.
- In FY26, the legislature again passed \$2.5 million, but signaled support by removing the word "pilot."
- Through Mass. Legal Assistance Corporation (MLAC), which funds civil legal aid organizations, 6 programs are representing low-income tenants and 1 is representing low income owner occupants.
- Funding modest, but work to provide tenants with full representation is beginning.
