ANNETTE R. DUKE has been a staff attorney at Massachusetts Law Reform Institute, a statewide advocacy and policy center, since 1988. She has been editor of *Legal Tactics: Tenants' Rights in Massachusetts* since 1993 and has developed numerous community legal education materials for tenants and community groups. She coordinated a successful campaign for statewide housing courts and is currently working on legislative campaigns for access to counsel, eviction record sealing protections, and protections for public housing tenants facing redevelopment.

TODD KAPLAN is a Senior Attorney in the Consumer Rights Unit at Greater Boston Legal Services. He co-counseled with the National Consumer Law Center and a civil rights law firm: Cohen-Milstein in a successful statewide class action challenging tenant screening practices in federal court and continues to challenge tenant screening.
