COMMISSION FOR DEAF AND HARD OF HEARING ISSUES 'SAVVY CONSUMER GUIDE TO HEARING LOSS'

BOSTON – The Massachusetts Commission for the Deaf and Hard of Hearing (MCDHH) today announced the publication of its updated *Savvy Consumer's Guide to Hearing Loss*. The new guide serves as a reference tool specifically for individuals who have lost all or much of their hearing during their teenage or adult years. Topics include the impact of hearing loss; available resources and services; communication options; assistive technology; and coping strategies.

"Each year, hundreds of people with hearing loss in Massachusetts contact the Commission for the Deaf and Hard of Hearing in search of information, resources and strategies for managing their disability," said MCDHH Commissioner Heidi L. Reed. "Our goal in publishing the *Savvy Consumer's Guide* is to offer the most comprehensive, insightful and practical information available for adapting to life with hearing loss."

Dr. Karen Rochow, Ph.D., who authored the updated guide, added, "No one is born knowing how to cope with hearing loss. We need information and support from those who have traveled this road before us, and we need to learn how to live by a new set of rules."

This second edition was updated to reflect changes in communication access, technology and available resources. First published in 1997, the *Savvy Consumer's Guide* is the Commission's most frequently requested publication, with over 50,000 copies in circulation.
