ANNA SCHLEELEIN RICHARDSON is a graduate of Boston College and Boston University Lawe School and is the-Executive Director & Chief Counsel of Veterans Legal Services. Anna Richardson became co-executive director and chief counsel at VLS in 2010, after previously serving as a staff attorney. In 2019, she was named co-Lawyer of the Year by the Frank J. Murray Inn of Court and was also a *Massachusetts Lawyers Weekly* "Top Women in the Law" honoree. In addition to her legal work at VLS, Anna has led trainings on veterans' legal issues for the Boston Bar Association, the Legal Advocacy and Resource Center, and various legal services agencies throughout Massachusetts.

She currently serves on the board of the Mental Health Legal Advisors Committee, appointed by the Massachusetts Supreme Judicial Court and also serves on the Massachusetts Bar Association Family Law Committee. (June 2024)

PATRICK GEORGE is the Director of Veterans' Services for the City of Watertown.
