To: **Transitional Assistance Office Staff** Joyce Sampson, Assistant Commissioner for Field Operations From: New and Redefined Food Stamp Work Program Eligibility Re: Action Reason Codes To accurately monitor and track Food Stamp Work Program Background (FS/WP) cases, Systems User's Guide Update 120 transmits revised Category 9 Eligibility Action Reasons. Action Reasons 05, 06 and 08 have been redefined. Action Reasons 07 and 11 have been added. The pages from Systems User's Guide Update 120 which contain the revised Action Reasons are attached. These new codes are now operational and should be used *immediately* when coding new and reopened food stamp cases. Ongoing cases should be reviewed at the *next recertification or* during case maintenance activity and the coding changed, if appropriate. Revised FS/WP procedures incorporating these new and redefined codes will be issued. LOQC Special For the past two months, LOQC has reviewed food stamp Project cases containing recipients age 18-50 to ensure correct Food Stamp Work Requirement coding. LOQC will begin to visit TAOs to recode ongoing FS/WP cases across the state, when appropriate, using the new and redefined codes.
