Holyoke Regional Homeless Unit

Overview

The Holyoke Regional Homeless Unit has been formed to accommodate and better manage the homeless population from the Springfield and Holyoke Transitional Assistance Offices. The Unit consists of five case managers and one supervisor. Effective December 29, 2008, all EA cases and corresponding cash and/or SNAP cases in the Springfield State and Springfield Liberty TAOs were transferred to the Holyoke TAO. EA applications taken in the Springfield TAOs on and/or after December 29, 2008 were processed and transferred to the Holyoke Regional Homeless Unit.

Prior to December 29, 2008, a letter (Attachment A) was mailed to all clients affected by this change, informing them of the transfer.

Case Manager and Homeless Coordinator Responsibilities

Case Manager For Springfield State and Springfield Liberty TAOs only:

If a family is eligible for temporary emergency shelter benefits, the case manager/Homeless Coordinator must follow current procedures to place the family in shelter. If in addition to applying for EA, the client also applies for cash and/or SNAP benefits; once the family is placed, transfer all cases immediately and Holyoke will process the pending cases.

For all TAOs, except Springfield State and Springfield Liberty TAOs:

The case manager/Homeless Coordinator for all EA families whose placement is in an area served by the Holyoke or Springfield TAOs must transfer these cases to the Holyoke TAO following current case transfer procedures.
