For ConnectorCare & Qualified Health Plans with Premium Tax Credits, eligibility is based on expected annual MAGI income with no 5% of poverty level income deduction. 2017 FPL levels are used until the next open enrollment in the fall of 2018. Children with income over 405% of the poverty level can buy-in to the Children's Medical Security Program (CMSP) at full cost.

There is no income upper limit or deductible for disabled children or disabled adults in CommonHealth.

The CommonHealth deductible income standard for nonworking adults is \$542 per mo. for one person & \$670 for a couple

The upper income level for PACE and other home & community based waiver programs is \$\$2,250 monthly in 2018.

The 2017 poverty levels were published in the Jan. 31, 2018 Federal Register, 82 FR 8831.
