**Overview** 

Recent enhancements between DTA and Department of Revenue Child Support Enforcement Division (DOR/CSE) have improved the exchange of information between the agencies.

Effective immediately, staff must not mail, fax, or email DOR/CSE child support requirement documents: T-A34/36 forms, NFL-14 forms, Massachusetts birth certificates, etc. As the information contained on those forms is available in BEACON, it is shared as part of the weekly interface process.

However, when clients submit *Mother's Affidavit* forms, DOR-CN forms, and out-of-state records of birth, marriage, divorce, death, etc., they must be mailed to DOR/CSE. Please mail to:
