Re:	Homeless Child Care Obsolete Field Operations Memos, Other Obsolete Homeless Child Care Documents and Homeless Child Care Services Available through DHCD
Overview	On July 1, 2009, the Emergency Assistance (EA) program transitioned from DTA to the Department of Housing and Community Development (DHCD). All of the eligibility and case management services and activities associated with the EA program became the responsibility of DHCD.
Purpose of Memo	The purpose of this Operations Memo is to inform TAO staff of obsolete Field Operations Memos and other obsolete documents relating to the homeless child care services that were formerly provided through DTA. The memo also serves to communicate the homeless child care services available to DTA homeless families through DHCD and how families access the services.

DTA Child Care Any TAFDC client who is employed or in an ESP activity regardless of whether (s)he is homeless or not, is eligible for ESP child care. Any former TAFDC client who is employed regardless of whether (s)he is homeless, is eligible for Transitional Child Care (TCC) for up to 12 months from the date of the TAFDC closing.

DHCD HomelessChild CareServicesCurrently, the Department of Early Education and Care (EEC) authorizes a limited number of child care slots with child care providers for eligible children of homeless families. These child care slots are contracted with specific providers and are not accessed through a child care voucher.

DHCD certifies for EEC that each of the families referred to these slots:

- is in an EA shelter, or
- has recently left an EA shelter for a short-term subsidy unit; and
- is not eligible for child care assistance through DTA.

To obtain a homeless child care slot, a homeless family should speak with shelter provider staff, F.O.R. Families staff, or a child care provider regarding the family's child care needs. Staff from these agencies may send a DHCD homeless child care referral form to DHCD's Central Office for approval.

DHCD Homeless Child Care Services (continued)	However, because of the limited number of slots, DHCD maintains a waiting list of referred families. Periodically, EEC will furnish DHCD with a list of vacant slots. DHCD will approve a family on the waitlist to fill a slot when an appropriate slot becomes available.
	DTA homeless families who request homeless child care services will be referred to DHCD by the shelter, F.O.R. families, or the child care provider if the family is not in receipt of TAFDC and does not have TCC, or is in receipt of TAFDC but does not have ESP child care.
	Note: The Child Care Resource and Referral (CCR&R) agencies are not involved in the homeless child care process.
