Federal courts are, with increasing frequency, ordering that Equal Access to Justice Act fee awards be sent to plaintiffs. While this issue is wending its way to the Supreme Court, legislation is pending before the House of Representatives.

Rep. Peter DeFazio (D-OR) has introduced H.R. 5833, a bill that clarifies that an EAJA award is an attorney's fee payment. The bill has been referred to the House Judiciary Committee's Subcommittee on Courts, the Internet, and Intellectual Property. The bill now has 13 co-sponsors, as noted in the attached.

Please urge your Representative to co-sponsor this important bill. Without it, we will see many fewer claimants able to have their cases reviewed in federal court because they won't be able to find lawyers.

Section 2412 of title 28, United States Code, is amended by adding at the end the following:

'(g) In a civil action brought under section 205(g) of the Social Security Act (42 U.S.C. 405(g)) in which a prevailing party other than the United States is represented by an attorney, any costs and fees awarded under this section to such prevailing party--

- `(1) shall be paid directly to the attorney representing the prevailing party; and
- `(2) shall not be subject to offset under section 3716 of title 31, United States Code, due to a claim of
